

5. Place for submitting the tender : Police Head Quarters, Bihar, Old Secretariat, Patna.
6. Description of work :-

As directed by Ministry of Home Affairs, Government of India, Special Group Insurance cover has to be provided to a total number of 49,432 police officers and police personnel of District Police Force, Bihar Military Police, Bihar Home Guards, SAP, CRPF, CoBRA, Rail Police (GRP) and STF, who are deputed for anti-naxal operations in the 16 naxal affected districts covered under SRE scheme - Patna, Nalanda, Gaya, Aurangabaad, Rohtas, Kaimur, Bhojpur, Nawada, Jehanabad, Arwal, Jamui, Munger, Motihari, Sitamarhi and Bettiah (including Police District of Bagha as well as Rail District of Patna and Jamalpur).

The compensation shall be paid directly to the person insured in case of injured or handicap; and to his/her legal heir in case of death of an insured officer/personnel.

The insurance amount has to be mentioned against the premium value as per the following table:-





Terms & Conditions for Insurance of Bihar Police

1. The tender should be submitted in two parts, (1) Technical bid (2) Financial bid. Technical bid should contain all relevant documents and the technical specifications of the proposed insurance in accordance with the tender.
2. The technical bid and financial bid must be submitted separately, in two separate sealed envelopes and the envelopes should be marked "Short Tender No. 11 / 2014-15 (Technical bid) and Short Tender No.11/2014-15 (Financial bid) along with the name and address of the tenderer.
3. The sealed envelopes containing the technical and the financial bid should be placed in another sealed envelope which should be marked as "Short Tender No. 11/2014-2015.
4. The envelope should not bear the name and address of the tenderer. If the financial bid is submitted in the same envelope containing the technical bid then it shall be summarily rejected.
5. The Technical bids received will be opened on 20/03/2015 At 16:00 PM in the office chamber of the undersigned.
6. Representative of the tenderers may remain present at the time of opening of the technical bid and may be required to participate in discussions with the designated authority.
7. The financial bids of only those tenderers shall be opened who have been short listed after consideration of the technical bid. All valid tenderers will be given notice of the date and time for opening financial bids.
8. The premium tendered for the proposed insurance should be quoted indicating all taxes clearly and separately. Vague offers indicating taxes "as applicable" will be summarily rejected.
9. If there is any discount in the premium for the policy, it should be deducted from the tendered premium itself and should not be quoted separately.
10. The successful bidder will have to enter into an agreement with designated authority of Bihar Police.
11. D G of Police, Bihar, Patna reserves the right to reject any or all the tenders partially or fully without assigning any reason there of.
