Suh: Functions of Anti Corruption Cell.

Consequent upon the creation of the Anti-Corruption Cell of the Binar Police in the C.I.D. the following functions are asigned to it:-

- (a) Create such conditions of service as would reduce the scope of corruption and with this end in view maintain a closer and tighter control over the conduct of its officers and men.
- (b) Bring up cases of corruption either suo moto or on receipt of complaint and pursue it to its logical end.
- 2) To the above end the Anti Corruption Cell would take up :-
 - (a) Collection of intelligence.
- (b) Enquiries in 0 complaints of corruption, mal practices, wis conduct and micuse or abuse of authority from the vigilance point of view within the meaning of the Prevention of Corruption Act.
- (c) Appraised of coope, extent and points of corruption in the department and adoption of preventive measures with a view to eliminating corruption and other malpractices.
- (d) Collection of information regarding gambling dens and illicit sale of liquer, opium, charas and other forms of narcotics with committance of the local police.
- (e) Preparation of the list of officers of doubtful integrity.
- (f) Scruting of property statement of police officers with a view to finding out undeclared ascets or assets disproportionate to their known sources of income.
- (5) Investigation of cases arising out of corruption and criminal dis-conduct.

- (h) Surprise checks of police stations and posts on receipt of complaint or information regarding corruption, mal-practices and gross abuse of authority.
- (i) Surprise raids and traps under the Prevention of Corruption Act and Dangerous Drugs Act, Excise Act and other connected Acts.
- The Anti Corruption Cell will have a flying squad 3) which will attend to the grievances of public relating to illegal detention, harassment, corruption and malpractices at the hands of the police officers and men.
