



1. Name of department :- Office of the Director General of Police, Bihar, Patna

5. Description of work:-

As directed by ministry of Home Affairs, Government of India, Special Group Insurance (for period of dt-01-07-2017 to 31-06-2018) cover has to be provided to a total number of 68,648 Police officers and police personnel of District Police Force, Bihar Military Police, Bihar Home Guards, SAP, CRPF, CoBRA, Rail Police (GRP), STF, SSB, CID, Spl. Branch (BDDS), SSG, ATS & All Police Who are deputed for anti-naxal operations in the 23 naxal affected districts covered under SRE scheme namely- Muzaffarpur, Sheohar, Vaishali, Banka, Lakhisarai, Begusarai, Khagaria, Patna, Gaya, Arwal, Rohtas, Jamui, Munger, Kaimur, Bhojpur, Nawada, Jehanabad, Motihari, Sitamarhi, Bagaha, Bettiah, Nalanda & Aurangabad (including Rail District of Patna, Jamalpur & Muzaffarpur).

The policy will provide for payment of compensation in the event of Death/Disability including hospitalization expenses resulting solely and directly from accident caused by external, visible & violent means and Death/Disability including hospitalization expenses attributable to sun stroke and heart attack whilst on anti-naxal operation/ or extremist attack in and out of the naxal infested districts of Bihar as mentioned above. The coverage under the policy shall extend to the adjoining districts within Bihar and other state/country during anti-naxal operations either independently undertaken by state or jointly subject to certification of Superintendent of Police concerned in this regard provided personnel is primarily working in the above mentioned SRE district including Rail districts. In special circumstances in any attack by naxals in non-SRE district, if specialized force located in SRE district is sent to fight out the naxalites in that operation in non-SRE are (within Bihar), then this specialized security personnel will also be entitled to group insurance benefits.

The insurance amount has to be mentioned against the premium value as per the following table:-

Terms & Conditions for Short Tender Notice No-10/2017-18

1. The tender should be submitted in two parts, (1) Technical bid (2) Financial bid. Technical bid should contain all relevant documents and the technical specifications of the proposed insurance in accordance with the tender.
2. The technical bid and financial bid must be submitted separately, in two separate sealed envelopes and the envelopes should be marked Short Tender No-10/2017-18 (Technical bid) and Short Tender No.10/2017-18 (Financial bid) along with the name and address of the tenderer.
3. The sealed envelopes containing the technical and the financial bid should be placed in another sealed envelope which should be marked as short Tender No.10/2017-18
4. The envelope should not bear the name and address of the tenderer. If the financial bid is submitted in the same envelope containing the technical bid then it shall be summarily rejected.
5. The Technical bids received will be opened on / /2017 At 04:00 P.M in the office chamber of the undersigned.
6. Representative of the tenderers may remain present at the time of opening of the technical bid and may be required to participate in discussions with the designated authority.
7. The financial bids of only those tenderers shall be opened who have been short listed after consideration of the technical bid. All valid tenderers will be given notice of the date and time for opening financial bids.
8. The premium tendered for the proposed insurance should be quoted indicating all taxes clearly and separately. Vague offers indicating taxes "as applicable" will be summarily rejected.
9. If there is any discount in the premium for the policy, it should be deducted from the tendered premium itself and should not be quoted separately.
10. The successful bidder will have to enter into an agreement with designated authority of Bihar Police.
