## TERMS & CONDITIONS FOR THE TENDER NO.01/2013-14

1. Tender of the firms situated inside / outside the state will be accepted with the condition that if their tenders are successful the firm shall get itself registered with Commercial Tax Department Bihar before the purchase order issued.
2. Only such manufacturers / authorized dealers / agents who fulfill the above condition should quote for their vehicles.
3. The tender should be submitted in two parts, (1) Technical bid (2) Financial bid.
  - i. Technical bid should contain all relevant documents and the technical specification of the vehicles and should include other things:-
    - a. Ground clearance, b. Shock absorber capacity, c. Suspension capacity, d. seating capacity, e. Engine specifications (cubic capacity; BHP; Torque), f. Gear Box specifications, g. Tyre Size, h. Brake specifications, i. Type of body (steel/aluminum/Bolt on chassis/Monique), j. Operational manoeuvrability (Turning Circle), k. Running cost of vehicle per k.m. (Fuel consumption), l. Maintenance cost per 10,000 k.m. (spares and consumables), m. Warranty; n. A list of service centers located in Bihar.
4. The technical bid and financial bid **should be submitted separately**. If the technical and financial bid is submitted together (in same envelope) then it shall be summarily rejected. If the financial bid is submitted in the same envelope containing the technical bid then also it shall be summarily rejected. So financial bid be submitted in separate envelope.
5. The technical bid and the financial bid should be put in two separate sealed envelopes and the envelopes should be marked " Tender No-01 /2013-14 (Technical Bid) and Tender No-01/2013-14 (Financial Bid) along with the name and address of the firm. The sealed envelopes containing the technical and the financial bid should be placed in another sealed envelope which should be marked as " Tender No-01/2013-14". This envelope should not bear the name and address of the firm.
6. If the vehicle being manufactured is a patented / proprietary vehicle then a certificate to this effect should be provided by the manufacturer.
7. The technical bid will be opened first and after analysis it will be put in Central Purchase Committee. The firm may have to participate in discussions with this committee and / or be required to display the quoted product.
8. The firm should give all relevant data and specifications to prove that the vehicle being offered is best suited for the specific requirements mentioned in the table above.
9. The financial bid of only those firms shall be opened who have been short listed by the above committee on preassigned date and time giving notice to the table above.
10. If the product is on DGS&D rate contract then the copy of the contract be attached and pricing be done with all taxes including Bihar Sales Tax.
11. All Items will be received at Central Clothing Store, Patna. The price of the vehicles should be quoted indicating taxes, transportations and freight charges. All taxes and duties must be indicated clearly and separately. In case of vague offers indicating taxes "as applicable" will be summarily rejected. Price should be quoted F.O.R. Central Clothing Store, Phulwarisarif, Patna.
12. Up-to-date Income Tax returns and copy of PAN of the participating firms should be submitted with the technical part of the quotation.
13. A copy of the profit and loss A/c of the firm for the last financial year should be submitted along with the tender for verification of the claimed turn over.
14. Firms will have to supply all the vehicles within a week from the date of placing purchase orders. Payment will be made after the delivery of vehicles.
15. **Firms will have to deposit a sum of rupees 25000/- (Twenty five thousand) only as an earnest money in the shape of postal saving passbook / NSC/Bank draft duly pledged in favour of the undersigned along with the quotations.**
16. Technical bids received will be opened on 02/05/2013 at 16.00 hours in the office chamber of the undersigned. Representative of the tenderers may remain present at the time of opening of the technical bid.
17. If there is some discount in the price of any vehicles, it should be deducted from price itself and should not be quoted separately.
18. Successful firm will have to enter into an agreement after depositing a sum of 5% of the total value of the stores as security money in the shape of Postal Saving Passbook/NSC/Bank Guarantee duly pledged in favour of undersigned and will have to provide after sale service also.
19. D.G. of Police Bihar, Patna reserves the right to reject any or all the quotations partially or fully without assigning any reason thereof.
20. The Quantity indicated may increase or decrease at the time of issuing purchase order.
