





Course: Chemical, Biological Radiological and Nuclear-Operations (CBRN-O) (ATA-10413)

Duration and Dates of Course: Three week: April 20 to May 8, 2015

Location: Any police Academy in India.

Number of Participants: 24

Number of Reserve Participants: 10

The following information is provided to give you a better perspective of this course:

1. COURSE DESCRIPTION AND OBJECTIVES:

This three-week course is designed to enhance the response capability of the partner nation by training teams of operational responders for incidents involving chemical, biological, radiological, or nuclear (CBRN) materials. Relying primarily on field exercises with supplemental lecture, this course will prepare participants to execute fundamental hazardous material and emergency management response procedures that can mitigate loss of life in a CBRN or hazardous materials (HAZMAT) incident.

DS/T/ATA policy requires course participants to attend the entire course. The training value diminishes if a participant is required to perform his/her daily operational duties while attending this course. Participants who miss any module, for whatever reason, may not be allowed to return to finish the course.

ATA programs adhere to the "train-the-trainer" methodology and the GOI is encouraged to nominate trainers and/or instructors as participants. This will facilitate India's development of a viable antiterrorism training program within its law enforcement community. Officers selected for this course should remain in their positions for a minimum of two years. **They should be holding a rank from Deputy Superintendent of Police to Inspector General of Police**

3. PARTICIPANT INFORMATION:

You are requested to forward the name, rank, date/place of birth, and current position title and unit of each participant selected for this course. This should be submitted by March 13, 2015.

GOI must also provide this biographic data for reserve candidates for this course. These reserve candidates must be approved and vetted, along with the list of primary participants, prior to the commencement of training, however, they will NOT/NOT attend or participate in the training unless a candidate from the primary list is unable to participate due to vetting, medical, or other issues. It is imperative that the invited country understand that providing alternate names does not guarantee these candidates will receive ATA training and they should not be sent for training unless one of the original participants is dropped from training prior to the commencement of the course. Once the course/activity is in progress alternate candidates will not be authorized to attend.

DS/T/ATA requires the GOI appoint a senior leader for the group. This individual should have the authority to maintain class order and discipline.

4. COURSE LANGUAGE:

This course will be taught in English. All materials will be in English.

5. RESOURCE REQUIREMENTS:

DS/T/ATA prefers that the Partner Nations share the costs of training. The Partner Nation may provide this support by hosting the course at a Partner Nation facility.

Partner Nation must provide or arrange for the following resources:

Classroom facility that:

Accommodates up to 24 participants, 4 facilitators

Course topics and activities during the first week focus primarily on improvised explosive device (IED) awareness, toxic industrial chemicals and materials (TICS/TIMS), CBRN risk assessment and awareness, crime scene issues, chemical hazard detection and prediction, triage, search and rescue operations, and equipment maintenance. During the final two weeks, the participants are divided into teams for course mock-up exercises that require them to make difficult decisions and carry out essential functions through scenario-driven incidents. The participants are challenged to maintain a common, coordinated response to a terrorist incident of national significance.

At the conclusion of this course, participants will be able to: differentiate between HAZMAT and CBRN incidents; perform HAZMAT operations based on United Nations (UN) standards; respond to HAZMAT and CBRN incidents involving mass casualties in a manner that minimizes loss of life; and apply emergency management procedures based on the partner nation's operations plan.

Training hours are 8 a.m. to 5 p.m. Monday through Friday for the first week of training. The final two weeks will require work hour adjustments to accommodate the course exercises (low-light/no-light), which will require later start and end times; however, start times and days may be adjusted depending on local customs.

DS/T/ATA does not prohibit the videotaping of the training courses by the Partner Nation (PN) for the purposes of providing training reinforcement and enhancing sustainment capabilities of the material presented. All ATA-sponsored courses, consultations, and seminars are unclassified, but carry the additional distribution restriction of "Law Enforcement Sensitive." Prior to any videotaping, the requesting PN must agree in writing to the resident RSO Office that the recorded information is not to be released to news services or the public. On a case by case basis, all requests will be forwarded to the Training Delivery Officer (TDO) for evaluation and potential DS/T/ATA clearance.

2. PARTICIPANT CRITERIA:

This course is designed for 24 public safety (fire services), HAZMAT team members, security (police), and emergency medical personnel directly responsible for responding to and safely resolving an incident involving CBRN agents or weapons. Participants should have attended ATA's CBRN Awareness course.

Department policy prohibits personnel assigned to an intelligence agency or military unit from participating in any ATA training/activity. Therefore, neither the GOI nor Post should propose such individuals for this training event. Personnel assigned to an intelligence unit within a law enforcement organization, and who support the law enforcement function of that organization, are acceptable. Personnel assigned to a military unit that performs a law enforcement function are acceptable.

Is configured into a U-shaped design with adjustable lights to facilitate use of projection equipment as well as ability to read course materials

Has an adjacent area to temporarily store and train with the RRT, such as a large, open field with buildings suitable for day and night exercises

Can be secured overnight so that course materials can be stored in the classroom and remain safeguarded

Has area immediately adjacent to provide for three breakout rooms (classroom can be used for one breakout group if necessary)

Provides space, power, and air conditioning to support computer equipment, projectors, and audio equipment

A podium, lectern, and flat utility table(s) to accommodate presenter laptop computer and projector

Whiteboard or easel with flipchart (post-it type to attach to the wall or provide scotch tape)

Large marking pen sets for the flipchart or whiteboard

Note pads for participant note taking

DS/T/ATA appreciates Partner Nation support in arranging administrative and logistical support for this course.
