

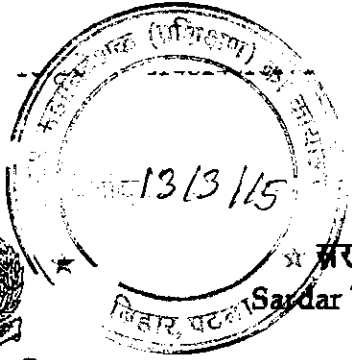

A Five day course on "Economic Offences" is scheduled to be held at SVP National Police Academy, Hyderabad from May 11-15, 2015 for Police Officers of the rank of SP and above from the States, CPOs and Bank Officers (Public Sector Undertakings, Nationalised Banks).

2. The Objectives of the course are to enable the participants:

- To have a better understanding about the genesis and magnitude of economic crimes.
- Review the existing laws, policing, procedures and other control mechanisms for tackling such crimes
- Analyse the limitations and constraints in enforcement and to suggest ways and means for their resolution and
- Appreciate current and future trends in economic crimes with a view to exploring new strategies and tactics for effective tackling of such crimes.

3. It is requested to nominate Police Officers of the rank of SP and above from the States, CPOs and Bank Officers (Public Sector Undertakings, Nationalised Banks) to attend the course as per the table below:

The nominees may be advised to proceed for the programme only after receiving confirmation of acceptance of their nominations from the Academy.

5. The Programme is fully residential and the participants of the course will be staying in the accommodation provided by the Academy. The expenditure to be incurred on boarding and lodging of the participants shall be met by the Academy, in respect of all Officers attending the course. However, the expenditure on account of travel of officers for attending the course may be borne by the respective State / Central Government Departments.

6. The Officers nominated for the course are required to report at the Academy by the evening of May 10, 2015 i.e. one day before the commencement of the course. Transport from Hyderabad Airport / Railway station to Academy and back will be provided by the Academy as per travel plan provided by the participants.
