



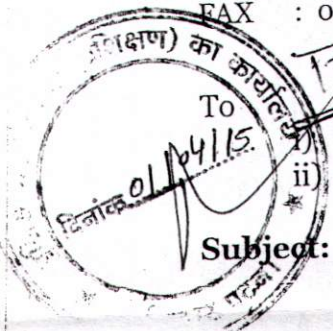

**Subject: Nomination for MBA (Disaster Management) Weekend Programme at Guru Gobind Singh Indraprastha University for the session 2015-17 – regarding.**

Sir,

Nomination of eligible Police officers is invited for **MBA (Disaster Management) Weekend Programme at Guru Gobind Singh Indraprastha University for the session 2015-17.**

2. Following is the eligibility criteria and conditions for the course:

(i)	Length of Service nominated	a. Minimum 7 years of Service b. Sub-Inspector & Above c. Should meet eligibility criteria of GGSIP University
(ii)	Upper Age Limit	<b>Below 50 years of age (53 for SC/ST) as on 01.07.2015</b>

3. As per the decision taken by the MHA, Govt. of India, BPR&D will bear the course fee only, which is as under:

- a. First Year – Rs.81,000(includes Rs.5,000/- refundable security deposit to be paid by individual. Thus BPR&D will bear cost of Rs76,000/- only)  
b. Second Year – Rs.75,000/-

The Sponsoring Organizations, namely, the organization where the official is currently posted, will meet the cost of:

- (i) **Pay and Allowances**  
(ii) Other charges, if any.

5. The selected officer shall give an undertaking:

- a) That his services can be utilized as **Resource Person** in the area of his specialization by the Central/ State Government Organization as and when required.  
b) That he will provide **his expertise** to the Central/State Government Organization as and when required.  
c) That he would **complete** the proposed training programme within the **stipulated period** and submit a copy of his thesis/research work to MHA/BPR&D so that it could be circulated to State/CPOs/CAPFs  
d) That **he shall not leave** the service within **three years** of the completion of the course. Thereafter, for the **next three years**, if he leaves the service, he shall be required **to refund the half of the total cost** (cost of training plus Pay & Allowances etc.) incurred on him during the training programme.
