



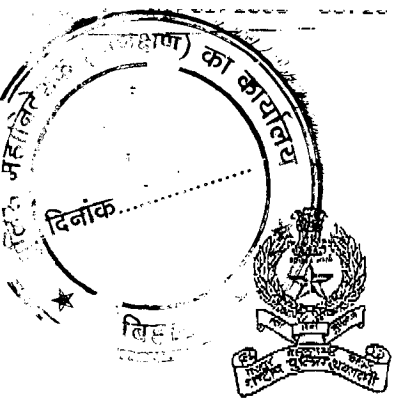

Community Policing is a policy and a strategy aimed at achieving more effective and efficient crime control, reduced fear of crime, improved quality of life, improved police service and police legitimacy, through a proactive reliance on community resources that seeks to change crime causing conditions. This assumes a need for greater accountability of police, greater public share in decision making, and greater concern for civil rights and liberties.

2. A seminar on "Community Policing" is scheduled to be held at S.V.P. National Police Academy, Hyderabad from June 29- 30, 2015 for the officers of the rank of Superintendent of Police & above from the States/UTs and officers of the rank of 2 I/C & above from CAPFs/Other Organizations.




