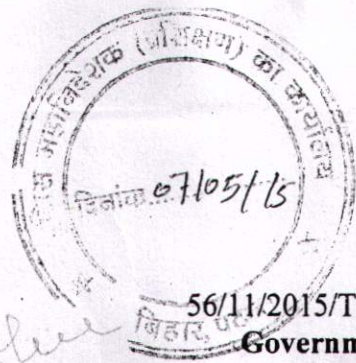

Homeland Security Investigations (HSI) under Department of Homeland Security (DHS) and Customs and Excise Department of Hong Kong, China are co-hosting the Asia- Intellectual Property Enforcement Workshop from June 23-25, 2015.

(a) Venue:

The Workshop would be held at a local Hotel ON Hong Kong Island (TBD).

(b) Duration & slots:

The duration of the course is 03 days (23-25 June, 2015). Only two slots have been offered for Indian Police officers.

(c) Training Charges:

The training, lodging, airfare and per diem charges shall be borne by HSI.

(d) Level of Participants/Criteria:

- i) The candidates should be of the rank of Inspector to DCP or equivalent ranks
- ii) The language of the course will be English and all the course material will be in English. So nominated officers should have requisite knowledge of English.
- iii) The nominated officers should be clear of vigilance angle.
- iv) Only officers who have investigated/supervised case pertaining to Intellectual Property Law and have acquired some expertise may be nominated.

(e) The participants have to give a 30 minutes presentation of case study of IPR Investigation.

- ii) Registration and Recordation
- iii) Exploiting Technology (ERTC)


